5.	Update on tasks – Briefing Notes issued for review by all. Foreword has been sent off, SEA is dependent upon Reg 14 and Crosses garage site. Social, Economic & Environmental Characteristics (SEE) has been submitted along with Design Intent, including Peter's comments. Reg 14 is pre-application – to check that all documentation is in place (Submitted via Parish Council as Steering Group is sub-committee to PC). Submitted for community to comment for 6-week period. Survey/questionnaire will be designed in similar format to previous. Must follow specific format from Briefing Notes document. Further information on where the plan can be viewed will be added. Review after 6 weeks to see if there are any amendments to be made, then submit Reg 15. Council appoint independent examiner and arrange referendum. Must state dates, telephone numbers, etc. Parish Clerk will email form to everyone on the list (consultees as per list distributed). PT raised that he had been through his notes and several people queried the map as it only showed the boundary and not SSSI/Historic sites, however LM confirmed that these would be added at a later date (check
